The Fund's biggest loser this month was a decline in our **call options on the S&P 500 Index** (0.9% of the Fund), which fell as the Index declined. This reduced the Fund's return by 1.2%.

Our main activity during the month was preparing a takeover bid by **Hamilton Securities** (4.2% of the Fund) for **Asset Resolution Ltd**, an unlisted Australian investment company. The takeover bid was formally launched on 7th April. The Fund owns 47% of Hamilton (on a fully diluted basis) and Fred is a director of Hamilton. The Fund already owns 18.5% of ARL, and ARL represents 9.2% of the Fund's assets.

The bid values ARL at \$9.8m, which is more than Hamilton's cash of \$2.6m. The difference is being funded by a loan facility from the Fund, which, if drawn upon, will be repaid by a rights issue to Hamilton shareholders, which the Fund will underwrite.

Depending on the outcome of the takeover bid and the rights issue, ARL (both directly and through Hamilton) could grow to over 35% of the Fund, which would make it by far the Fund's largest asset. I am happy to discuss the ARL bid with any unit holder who wishes to hear more about it and what it means for the Fund.

Most of the Fund's gain in March was due to us raising the price at which we value ARL shares to 1.0 cent (the bid price), compared to our most recent purchase price of 0.8 cent.

The Fund's net asset value per unit was \$1.5342 at month end. The Fund owned securities issued by 21 companies. 21.7% of the Fund was in \$A cash.
